Annual Meeting in Berlin, 13 September 2018, 3.15-4.45 PM

On 6th June 2018, the registered members have received an invitation to the **Annual Meeting** of **ReDi** that will take place on Thursday, 13 September 2018 (from 3.15-4.45 PM) during the ReDi Conference in Berlin. The Executive Board is asking the members for decisions in important organizational questions. These are, among others, the re-location of ReDi to Brussels, membership fees and the role of regional networks. The Annual Meeting in Berlin will become an important platform for choosing path to stabilize and develop ReDi as an international platform for research in the field of Diaconia and Christian Social Practice. ReDi Conference in Berlin, 12-14 September 2018

As always, the Annual Meeting is part of the program of the Biannual International Conference of ReDi. The Seventh Biannual Conference takes place from 12- 14 September 2018 in Berlin in the headquarters of Diakonie Deutschland. The theme of the Conference is "Beyond Services Towards Justice" (please have a look at the **conference programme**). It is still possible to submit abstracts for workshops, poster and paper sessions and research group meeting, see **call for papers**. However, you have to be quick if you want to be a contributor. The abstracts should be submitted until **15th June 2018 at the latest.** Abstracts for papers should be max. 200 words, proposals for poster sessions, workshops and research groups should not be longer than one page. Please submit your abstracts to Eurodiaconia's Research Officer Florian Tuder at florian.tuder@eurodiaconia.org. Full texts of the papers and posters should be submitted to the same address **by 29 August 2018**.
