Dear members and friends,

In this first newsletter since the Berlin conference we would like to offer a short summary of the conference and the General Meeting that took place during the conference.

The Biannual ReDi Conference was held in Berlin on 12-14 September, hosted by Diakonie Deutschland in Berlin. A new executive board was elected in the General Meeting. Also, the first Anders Bäckström Prize for excellent Master thesis was awarded. Last, but not least we will inform you about latest volume of the *Diaconia journal* and future events that ReDi is involved in.

The Seventh Biennial Conference for Research in Diaconia and Christian Social Practice in Berlin 12-14 September 2018

The Seventh Biennial Conference was a great success with nearly 90 participants and with interesting keynote lectures, presentations and discussions about social justice, theological perspectives and diaconia in both global and local contexts. The conference

was titled "Beyond services towards justice". We enjoyed the well-organized event hosted by Diakonie Deutschland in Berlin and the German team led by Dr Ingolf Hübner, Diakonie Deutschland and prof. Johannes Eurich, Diakoniewissenschaftlichen Instituts, Heidelberg.

The opening lecture on *Globalisation and Justice from a Theological Perspective* was given by **Dr. Isabel Phiri**, the WCC Associate General Secretary for Public Witness & Diaconia. The second keynote lecture *Precious and precarious: Tensions and possibilities in diaconal economics* was given by **Prof. Dr. Sturla Stålsett**, Professor of Diakonia, Religion and Society, Norwegian School of Theology, Oslo. The third and final keynote lecture on *Welfare, gender and the Crisis of Care* was given by **Prof. Dr. Helma Lutz**. Goethe-Universität Frankfurt am Main.

Six workshops with 12 presentations and eight paper sessions with 19 presentations were held during the Conference. Also a panel discussion was held with the topic of What is the study of Diaconia? What are key challenges for the development of Diaconia? What does the study of Diaconia do in this context (critical remarks on "Beyond service towards justice").
